A Message from the Individualized Funding Coalition for Ontario

Latest News!

There is a great deal happening these days – the list of things to stay on top of and be informed about



just keeps growing. This is the result of a great deal of advocacy and education over the years by people and families living with disability in Ontario. To our members who did their part – kudos. We have listed the latest breaking news first and then a summary of involvement and activities of IFCO, and finally information about our membership drive which is getting out of the gate late again this year!!

The Select Committee on Developmental Services released its final report entitled: *Inclusion and Opportunity; A New Path for Developmental Services in Ontario*. The report is attached with this email. A few highlights from the report of particular interest include recommendations that:

- would have the Ministry of Community and Social Services "support independent planning organizations whose role it is to guide individuals with the help of their families, friends and support network through key transition points so that the individual is supported throughout the course of his or her life" (page 9)
- would "ensure recipients of SSAH funding not lose that funding before Passport funding is in place and an individualized life plan has been completed with an independent planner" (page 10)
- "there be more flexibility in allowable use of Passport funding to meet individual needs" (page 10)
- "the implementation of full direct funding options be fast-tracked" (page 10)

The Budget has passed. This means that the \$810 Million investment in Developmental Services over three years will go forward. Highlights with the budget are that 21,000 families and individuals will receive direct funding in the way of Passport and SSAH over the next three years from this investment.

- 4,000 families with children who have disabilities will receive SSAH this year,
 with the balance of families on the waiting list receiving funds the following year.
- 3,200 adults with developmental disabilities will receive Passport funding this year. The waiting list for Passport will be eliminated in four years.
- 1,400 people needing with urgent residential needs will be supported during this three year investment.

Partnership Table Information

At the most recent MCSS Partnership Table meeting on July 17th we learned that most of the funding that is invested this fiscal year will go through the existing structures and systems – which may be more traditional in approach. However, MCSS would like to see investments that will result in change into the future and they have intentions of investing differently. MCSS is also putting hope in the Housing Task Force which will be looking at innovative housing responses as part of their work.

Institution Class Actions

There has been an extension of the claims deadline. Claims do not have to be submitted by August 5, 2014. People will have until November 30, 2014. Please see the boxed insert in this news brief as well as the attached document called: *Effective Practices to support institution class action claims*.

Institution class actions – news and ideas about how to assist

Please find attached an update containing information and ideas about how to support class members from Huronia, Rideau and Southwestern Regional Centres to make more effective claims.

While there is so much that is alarming about what we are learning, we are encouraged by the people we have met, who are finding better ways to support class members, their families and their allies.

This message contains some important news:

- Many people still don't know that there has been an extension of the claims deadline.
 Claims need not be submitted by August 5th. People have until November 30th to submit claims and we hope the additional time will promote better support.
- Accessing institution files is important. The government says that file requests must be made by August 5th to guarantee that people will get files by October 5th.
- The next site visits to the former Huronia Regional Centre will be Friday July 25th and Saturday July 26th from 10 am to 5 pm. You need not register in advance. Visitors should not need to explain why they are attending but if asked, explain that you are supporting class members. That role need not be direct, since there are many ways we all work to improve opportunities for these folks. (Future dates and arrangements are yet to be determined).
- We would welcome suggestions about trauma counselling and about wills and estates.
