
Our Accord

“The Individualized Funding Coalition for Ontario supports the self-determination of persons with disabilities.

We believe that all people should have control over decisions concerning:

- where they live,
- with whom they live,
- with whom they associate, and
- how they spend their lives.

In order to achieve this, we recognize that Ontario must develop a system of funding whereby the person requiring assistance, supported as appropriate by family and/or significant others, has access to and control over the funds allocated for their supports.”

In 1998, ‘In Unison’ was signed by the Provincial, Territorial & Federal Governments. It outlined the importance of participation, opportunities and portable supports for people with disabilities. IFCO agrees.

In 2010, Canada ratified the UN Convention on the Rights of Persons with Disabilities. Article 19 recognizes that: Persons with disabilities have the opportunity to choose their place of residence and where and with whom they live on an equal basis with others and are not obliged to live in a particular living arrangement; Persons with disabilities have access to a range of in-home, residential and other community support services, including personal assistance necessary to support living and inclusion in the community, and to prevent isolation or segregation from the community.



Values Matter

We believe that the implementation of individualized planning, support, and funding for disability supports must be based on the intentional values of:

- citizenship
- self-determination
- relationships, and
- community

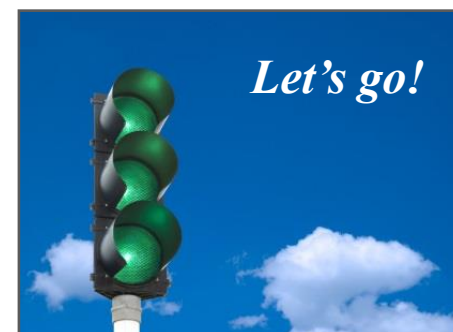
